The learned counsel for the respondent appears on advance service and status on instructions from Director(Projects) of MTNL states that appropriate steps will be taken within three (3) days to ensure that in future notifications no such condition excluding VRS 2019 retirees is included in the eligibility criteria.
- 3. The learned counsel for the respondent is directed to file a compliance affidavit to this effect within two (2) weeks and take steps for withdrawing the directive dated 25.06.2021.
- List for compliance on 30.05.2023.
- 2. Following action have been taken towards compliance of Hon'ble High Court order:
 - The advertisement for the engagement of consultant by Madhya Pradesh, Kolkata, Maharashtra and Assam LSAs have already been withdrawn in pursuance of this office vide OM dated 01.05.2023 (copy attached).
 - ii. The OM dated 12.05.2023 has been issued with the approval of Hon'ble MoC, which supercedes the OM dated 25.06.2021 and states that optees of BSNL/MTNL under VRS scheme 2019 may be considered for engagement on consultancy/contractual basis in any CPSE/Government department (copy attached).
- 3. In view of the above, it is requested that the necessary action may kindly be taken towards filing of compliance affidavit, in consultation with Govt. Counsel, please.

The undersigned is directed to refer to the subject mentioned above and to state that Hon'ble High court in its judgement dated 12.01.2023 (copy enclosed) has held that:

2 5 The resultant position which emerges is that the engagement of petitioners who are BSNL VRS-2019 retirees in any CPSE/Government department on contractual/consultancy basis, for which the retired employees on superannuation in due course are eligible for consideration, is not in violation of Clause 8 (iii) of BSNL VRS-2019.

It is accordingly held that clarification/directive dated 25.06.2021 interpreting the definition of employment/re-employment to include engagement on contractual / consultant basis is contrary to the terms and conditions of BSNL VRS-2019. The applicants as such are eligible to be considered for appointment consultancy/ contractual basis. The petition is accordingly allowed to aforesaid extent...

- 2. It has come to our notice that some of LSA like Bhopal, Kolkata, Pune, Guwahati etc have advertised citing the DoT O.M dated 25.06.2021 for post, wherein VRS optees are not eligible.
- 3. As the matter is still under deliberation/decision in DoT in consultation with DoPT, it is requested to instruct all the field units/offices to withdraw their advertisements till further instructions.
