Subject: Facilities for CMD and Full-time Directors of BSNL Board-Review and Consolidation.

Management committee of BSNL Board in its 330th meeting held on the 28th day of July, 2017, is pleased to review existing facilities for CMD and Full-time Directors of BSNL Board and CVO contained in different orders and an integrated order detailing facilities is as follows, the same shall be applicable with immediate effect:

Facility	Existing	Revised
<u>Service Telephone Facilities.</u> (<u>Landline-Broadband</u>)	-DEL[with STD and ISD facility][Listed] with usage limit of 2000 MCUs per month -DEL[with STD and ISD facility][Un-listed] with usage limit of 2000 MCUs per month. [Vide PHA Circular No. 2-3/2006-PHA dated 20.09.2007.]	-Existing policy of 2 Landline connections with STD, ISD shall continue with the modifications that Broadband on both the Landline connections will be provided with usage limit as per actuals.
<u>One separate Broadband.</u>	-Tariff Plan TriB 1999 with 2Mbps Speed or any other suitable plan if the individual CMD/Director so desires considering his usage pattern. [Vide PHA Circular No. 2-6/2005-PHA dated 17.11.2008].	-On need basis with the approval of CMD.
<u>FTTH Facility</u>	FTTH facility for CMD,BSNL [Vide No. 15-13/13-PHA dated 16.02.16]	On need basis with the approval of CMD.
<u>Mobile connectivity</u>	-01-MTNL[with STD and ISD, National and International Roaming, GPRS, MMS and 3G facilities] with usage limit of Rs.3000/- per month. [Vide PHA circular No. 2-3/2006-PHA dated 20.09.2007 and No. 2-3/2006-PHA dated 22.07.2008]	-Both MTNL's and other Private operator's SIM on need basis.

	-01 private operator SIM: individual can opt from any of the private operators. -01 BSNL SIM on need basis. [Vide PHA circular No. 03-01/2016-PHA dated 29.07.16]	
<u>I-Pad Plan</u>	-01 Micro SIM under plan 999 with 10GB data usage for I-pad from Haryana circle. [Vide no. BSNL/ SECTT/ Extract/ 256/ MCB/02 dated 18.09.15]	-On need basis with the approval of CMD. [Micro SIM from Haryana circle,]
<u>Mobile Handsets</u>	<u>Total No. 02 Once in three years</u> -One for MTNL -One for other SIM from private operator. (a) Financial Limit <u>CMD-For both sets --Need basis,</u> <u>Directors/CVO-</u> i) For one set- Need basis, ii) For Second Set Rs.50,000. [Vide PHA circular No. 03-01/2013--PHA dated 2.12.2013 and circular No. 03-01/2016-PHA dated 29.07.16]	<u>Total No. 02 Once in three years</u> -One for MTNL -One for other SIM from private operator. (a) Financial Limit <u>CMD-For both sets --Need basis,</u> <u>Directors/CVO-</u> i) For one set- Need basis, ii) For Second Set Rs.50,000.
<u>Change of Hand Set</u>	-The responsibility of the repair, replacement warranty, guarantee, theft, lost, quality and features etc lies with users. -Other terms and conditions governing policy regarding provision of Handset for GSM mobile service connection issued vide this office circular referred at 1 above shall remain unchanged. [Vide PHA circular No. 03-01/2016-PHA dated 29.07.16]	-Within one year on need basis, with the approval of CMD.

- In terms of DoPT's OM No. 372/9/2012-AVD-III dated 12.07.2012, CVO/BSNL shall be entitled to pay, status, benefits & perquisites admissible to the functional Directors of BSNL as detailed above.



- Procedures/modalities of providing the above-mentioned facilities not detailed hereinabove shall be guided by separate existing/revised office orders as the case may be.
- All charges shall be borne by BSNL. In case of refund of security deposit or any other charges by MTNL in the name of individual officer at the time of the closure of the connections, the same shall be refunded by concerned officer of to BSNL.
- These instruction shall be effective from the date of Issue of the circular.
- Competent Authority for release of sanction for service connections will be DGM[Admn].
