It is in continuation of our email dated 04-04-2023 on afore said subject. We once again extend our sincere gratitude and thanks to hon'ble Finance Minister and your good self for acceding our justification and demand raised through our earlier communications to raise the exemption limit from Rs 3 lakh to 25 lakh w.e.f 01-01-2016 and Rs 9 lakhs w.e.f 01-01-2006, which is on the basis of Income tax Act and earlier Notifications issued by CBDT on the subject.

Therefore in the light of the facts presented by this confederation through its letter dated 02-01-2023, and Hon'ble finance Minister's announcement in budget speech, your good self is requested to issue a fresh notification at the earliest under clause (ii) of section 10(10AA) of the Act, for enhancing the limit to Rs 25 lakhs w.e.f 01-01-2016 and Rs 9 lakhs w.e.f 01-01-2006 in line with 7<sup>th</sup> & 6<sup>th</sup> CPC implementation.
