Sub Sanction of WCs , based on very formidable and norm based justification, at Udaipur (Rajasthan) and Muzzafarnagar(UP) getting inordinately delayed for inexplicable and intriguing reasons.

Respected Madam

A very strong justification, based on the existing norms, has been sent by the Additional Directors/ CGHS, Jaipur and Meerut, to CGHS HQs for opening of WCs at Uaipur in Rajasthan and in Muzzafarnagar, UP.

The said proposals of the respective ADs/ CGHS have been sent to CGHSHQs a long time before but inexplicably and incomprehensibly no further action has been taken by CGHS HQs, thus resulting in huge anguish and resentment amongst CGHS beneficiaries at Uaipur and Muzzafarnagar and thousands and thousands of beneficiaries reising in areas adjacent to these two Central places places.

Needless to say, rather it is extremely pertinent to state, that the proposals have been forwarded to CGHSHQs by the respective ADs, based at Jaipur and Meerut, after very carefully examining that they meet fully the criterion and requirementd envisaged for opening of new WCs.

Even after that prolonged and unjustified delay in taking further action by CGHS HQs is really unfortunate, disappointing and very adversely reflects on the bureaucratic functioning of CGHS.

Besides this, what is extremely significant is that opening of WCs at these places is not going to cater to beneficiaries at these places alone but will provide relief and badly needed succour to thousands and thousands of CGHS beneficiaries living in non serviced CGHS areas adjacent to these places and facing incredible hardship to avail CGHS facilities.

Not only CGHS beneficiaries based at Udaipur and Muzzafarnagar and thousands and thousands of beneficiaries have no access to facilities but are being deprived of their legitimate right to have these facilities by way of not taking further action in this regard.

Against the backdrop of the above stated facts, your kind personal intervention is immediately solicited to ensure that an expeditious follow up action is taken on the proposals sent by ADs/ CGHS of Jaipur and Meerut. We are confident now that an early action would be taken and that the proposals will not continue to gather dust the way they are gathering for a considerable time. Inordinate delay in processing the proposals further is not only unfortunate and painful but the delay further aggravates the agony and hardships that beneficiaries at these places are confronted with. Concerned authorities in CGHS would do well to understand and appreciate this crucial and important fact.
