Sub Inordinate, incomprehensible and inexplicable delay, in complete defiance and total disregard of the instructions of Hon PMs office to address issues of Senior Citizens on highest priority, in issuing Presidential Orders for absorption in BSNL- Cases of Sh Kalu Ram Lodwal and Badri Lal Gautam, Retd SDEs of BSNL

The aforesaid officials having retired from BSNL as SDEs were not absorbed in BSNL because of pending prosecution cases against them filed by CBI. However, both these officials have been acquitted by the Spl CBI Court Jaipur in Oct, 23.

Since then the officials have been pleading for issuing of their Presidential Orders for absorption in BSNL and have repleted umpteen times with all the necessary and relevant documents, including acquittal Orders of the Court.

Unfortunately their repeated pleas to the concerned authorities in DOT for issuing of Presidential Orders for their absorption in BSNL is, as expected, falling on the deaf ears of the concerned officers.

The concerned officers are insensitive and indifferent towards the said officials to such an extent that they fail to recognize and realize that all the terminal benefits of the officials, including their regular pension, are withheld simply because of total negligence of concerned officers. This callous attitude of the concerned officers is in blatant violation and contemptuous disregard of the repeated instructions of the Hon PMs office that the issues relating to Senior Citizens and Pensioners need to be addressed on a war footing basis

The officials have made numerous representations to your office to address their grievance but unfortunately there has been as usual no response from your office.

The representations of the officials are once again enclosed herewith and your intervention is once again solicited to direct the concerned officers to issue Presidential Orders for their absorption in BSNL, without any delay whatsoever to enable them to get their legitimate terminal benefits and regular pension.
