This is with reference to PAT Section's OM No. 4-12(12)/2018-PAT-Part(1) dated 01.07.2019 (copy enclosed) vide which revised mapping as per 7<sup>th</sup> CPC for determining CGHS subscription and Ward entitlement to the retired BSNL/MTNL employees who are in receipt of pension from Central Civil Estimates was issued. Annexure 'B' of this OM is related to Entitlement of wards in private hospitals empanelled under CGHS for MTNL/ BSNL retirees.

2. In this matter, Department of Health & Family Welfare vide its OM No. S.11011/11/2016-CGHS(P)/EHS dated 28.10.2022 (copy enclosed) has revised entitlement of wards in private hospital empanelled under CGHS as follows:

Sl. No.	Corresponding Basic Pay drawn by Officer in 7 <sup>th</sup> CPC per month	Ward entitlement
1	Upto Rs 36,500/-	General
2	Rs 36,501/- to Rs 50,500/-	Semi-Private
3	Above Rs 50,500	Private

3. In view of above revised entitlement of wards in private hospital

empanelled under CGHS, Annexure 'B' of this office OM dated 01.07.2019 is required to be modified.

4. In this matter, corresponding basic pay in IDA pay scales of BSNL and MTNL w.r.t basic pay in CDA pay scale is required. It is requested to provide these details as per the Annexure attached. Further, methodology to arrive at corresponding basic pay in IDA scale may also be intimated to this office.
