Sub: Grant of increment to persons who completed one year service and retired on the eve of DNI in compliance to following conclusive Judgments of Hon Supreme Court and other Hon High Courts

Ref: 1. Judgement of Hon. Supreme Court in Civil Appeal No.2471 of 2023 @ SLP(C) No.6185 of 2020 dated 11th April 2023

2. Judgement on WP(C) 5320/2023 dtd 26/04/2023 of the Hon. Division Bench Delhi High court

Respected Madam

Kindly refer to the above judgements. The Hon Courts have directed that person's retired on the eve of their DNI are eligible for increment earned through service rendered for one full year as per Ref 1 and 2 above.

2. Judgement of the Hon. Division Bench of Delhi High Court has further adjudicated that this is applicable to all similarly placed persons and not limited to the applicants alone

3. The Court Judgements also direct U.O.I that it's applicability is for all who completed one full year of service on the eve of their retirement and not only to those retired on 30th June or 31st December

Since the judgements are absolutely clear beyond any doubt, we need not submit anything further. Our earnest request to your kind self is to issue necessary instructions to all the administrative ministries to implement these Judgments in letter and spirit and not to delay issuing of requisite instructions in compliance to the aforesaid Judgments since the implementation of these Judgments is

already inordinately delayed and that there is absolutely no rationale to further delay issuing of necessary instructions on the issue.

Needleess to say the aggrieved officials have been enormously suffering because of continuing and unwarranted delay in issing necessay instructions to comply with the aforesaid Judgments.

Expect that the matter will receive your kind, serious and expeditious personal intervention for its immediate resolution.
