Sub: Payment of Provisional Pension to retired ST officials of MH in accordance to Rule 62 of CCS PENSION RULES 2021.

Respected Madam

This is regarding payment of Provisional Pension to retired ST officials of BSNL. In this context, it is extremely important to reiterate the Rule 62 of CCS Pension Rules, 2021 which unambiguously states;

Although as per Rule 62 of CCS Pension Rules 2021, payment of Provisional Pension shall not continue beyond the period of six months from the date of retirement of Government Servant, ***the Rule provides that the Accounts Officer shall treat the Provisional Pension as final and issue Pension Payment order immediately on the expiry of the period of six months, if the final amount of Pension and Gratuity have not been determined by the Head of Office in consultation with the Accounts Officer within the aforesaid period of six months***

It is crystal clear from the above provisions of CCS Pension Rules 2021 that the entire responsibility of continuation of Provisional Pension lies on your office and that any discontinuation of Provisional Pension will be in total disregard and utter violation of Rule 62 of CCS Pension Rules 2021.

You are, therefore, requested to ensure continuation of Provisional Pension under all circumstances since the ***Onus of continuation of Provisional Pension entirely lies on your office and that any violation of Rule 62 would be contemptuous of Statutory CCS Pension Rules 2021 which, needless to say, have to be observed by your office with utmost sanctity.**
