The above mentioned beneficiary has been suffering from Breast/ Ovarian Cancer for last two years has been prescribed life saving drug, OLAPARIB 150 MG, four times a day by renowned Cancer Hospital, Indo- American Cancer Research Institute Hyderabad as well as Omega Hospital, Guntur Both the Hospitals are empanelled with CGHS.

AD/ Hyderabad has been uninterruptedly and very promptly issuing the said medicine to the beneficiary and that alone has ensured her survival for the last two years. It seems that AD/ Hyderabad has exhausted his prescribed limit to issue the prescribed medicine and has referred the case to CGHS HQs more than one and a half month alongwith all the requisite tests like PET SCAN, HISTOPATHOLOGY REPORT, BLOOD TESTS etc etc.

It is really shocking, regrettable and unfortunate that despite one and a half month having elapsed since AD/ Hyderabad has forwarded her case to CGHS HQs for taking appropriate expeditious action to ensure that the beneficiary, who is surviving exclusively

by taking the said prescribed medicine, is issued the life saving drug without any delay whatsoever.

An abnormal and unprecedented delay of more than a month is surely going to prove fatal for the beneficiary for which the responsibility will surely lie on the concerned officers dealing with such cases on highest priority.

Bureaucratic delays like this issue to be decided by a committee of experts cannot be cited and justified as reasons for such an abnormal delay in deciding a case where ones life is directly involved. This tantamounts to highest kind of wilful and unpardonable negligence.

In the context of aforesaid glaring facts, we seek your kind intervention on highest priority, without any delay whatsoever, to ensure that the said life saving drug is made available to the beneficiary at the earliest and earliest in this case means just within a couple of days.

We are confident of an expeditious action on a war footing basis haven't the nature of the case and its seriousness.
