Sub Request to accord approval to the proposal sent by AD/ Chandigarh on highest priority for empanelment of ALC Jammu for empanelment for Kashmir to supply medicines to Kashmir Valley.

Respected sir

Beneficiaries of Kashmir has been suffering miserably since last two years when empanelleled ALC was shot dead by terrorists in 2021.

After that, after intense persuasion by AD/ Chandigarh, existing ALC Kashmir was empanelleled after about 18 months

Unfortunately, the behavior of the existing ALC is highly erratic, irresponsible and, to say the least, irrational. Right from day one, the existing ALC has been arm twisting both CGHS authorities as well as the beneficiaries. Just after signing the terms and conditions of contract, he has been holding beneficiaries to ransom on flimsy grounds.

Recently, his outstanding bill of about Rs 4 lakhs was cleared to the extent of Rs 3, 6500 and for the remaining about Rs 36, 000 he was assured that amount would be cleared in a weeks time.

But even then he did not resume supply of medicines on irrelevant grounds as to why 2% TDS is deducted on the amount that is reimbursed to him by CGHS

Just to summarize the issue, it appears, by all means, that existing ALC at Kashmir is not at all interested in supplying the medicines.

The net result of this attitude of ALC is that the beneficiaries at Kashmir, who are already suffering miserably because not a single Hospital or diagnostic centre is empanelleled there, are urther subject to the worst kind of torture by stopping of supply of medicines by existing ALC for last three months.

In this connection, we understand that a proposal has been sent by AD/ Chandigarh to empanel ALC supplying medicines to Jammu for Kashmir Valley also. Existing empanelled ALC at Jammu is providing uninterrupted and hassle free supply of medicines at Jammu for quite some time now and has good credentials, is responsible and fully understands and appreciates the issues that arise from time to time.

It is humbly thus requested to get clearance of the proposal sent by AD/ Chandigarh on top most priority to mitigate the incredible sufferings of the beneficiaries of Kashmir.

We are confident, sir, that the issue will be treated with the kind of seriousness and urgency that it deserves for obvious reasons.
