In continuation of Office Memorandum F.No.5-34/CGHS/HEC(HQ)/2025 dated 28.03.2026 regarding Extension of Deadline, it is observed that the transition to the fully digital platform, along with detailed scrutiny of applications, is taking additional time due to both procedural and technical considerations.

2. In order to ensure continuity of healthcare services to CGHS beneficiaries during this period and to allow completion of the ongoing empanelment process in a comprehensive manner, it has been decided with the approval of the competent authority to extend the validity of empanelment of all existing CGHS empanelled hospitals.

3. Accordingly, the empanelment of hospitals currently on the CGHS panel is hereby extended up to 31st May, 2026.

4. **Action Required by HCOs:-** HCOs those have not yet submitted their fresh applications are directed to do so immediately. Incomplete applications must be finalized without delay. HCOs facing difficulties with HFR ID approval may take up the matter directly with their respective State ABDM nodal officers. This Directorate shall not be responsible for delays arising from failure to act in a timely manner.

5. All other terms and conditions of empanelment shall remain unchanged.

6. This issues with the approval of the competent authority.
